

**RESOLUTION NO. 9-2016**

**A RESOLUTION AUTHORIZING THE MAYOR AND THE CLERK OF THE VILLAGE OF ANSONIA, DARKE COUNTY, OHIO, TO ENTER INTO A CONTRACT TO ANSWER FIRE CALLS FROM RICHLAND TOWNSHIP, DARKE COUNTY, OHIO**

**BE IT RESOLVED** by the Council of the Village of Ansonia, Darke County, Ohio, that:

**SECTION ONE**

The Mayor and the Clerk of the Village of Ansonia, Ohio, are hereby authorized to enter into a contract with the Trustees of Richland Township, Darke County, Ohio, to answer fire calls from Richland Township, on the following terms and conditions:

The Village of Ansonia agrees to answer fire calls from said Richland Township and its inhabitants for the period of time and for the area designated for the purpose of extinguishing fires in said Township, in like manner as fire calls are answered and fires extinguished in the Village of Ansonia, Ohio, for the following period: From January 1, 2017, to December 31, 2017, in the following area: West-Beam Road; North-St. Rt. 47; East-Schroder & Younker Road; Southside of Oliver Road.

In consideration for which, Richland Township agrees to pay to the Village of Ansonia for said services an amount equal to fifty per cent (50%) of the proceeds received by the Trustees of Richland Township from any existing, or hereafter imposed, fire levies, specifically denominated as such, levied upon the taxable property situated in the township of Richland, Darke County, Ohio, as authorized to be assessed and collected by the vote of the electors of said township; but being limited to those proceeds actually received by the Trustees of Richland Township during the term of this contract; and regardless of the number of pieces of apparatus used in answer to a call, or the miles traveled by such pieces of apparatus from the fire house of said Village of Ansonia, the proceeds to be distributed by the clerk of Richland Township upon receipt of distribution from the County Auditor twice yearly. One half (½) of said sum shall be payable on or before June 15, 2017 and one half (½) of said sum shall be payable on or before December 15, 2017.

It is mutually understood and agreed that in no event shall the Village of Ansonia be liable in damages to said Township or any of its inhabitants, for failure to answer any fire call, or for lack of speed in answering any such calls, or for an inadequacy of equipment, negligent operation of apparatus, failure to extinguish any fire, or for any cause whatsoever growing out this contract, or for use of fire equipment or personnel of the Village of Ansonia.

**SECTION TWO**

It is further understood that this contract shall terminate upon the concluding date above set forth, unless the same is renewed in writing.


**SECTION THREE**
