

**ORDINANCE NO. 3-2021**

**AN ORDINANCE ESTABLISHING THE WAGE AND SALARY OF CERTAIN EMPLOYEES OF THE VILLAGE OF ANSONIA, OHIO AND REPEALING ALL INCONSISTENT LEGISLATION**

**BE IT ORDAINED** by the Council of the Village of Ansonia, Ohio, that:

**SECTION ONE**

**SALARY AND WAGE SCHEDULE**

The following hourly and salaried employees of the Village of Ansonia shall be paid at a rate determined from time to time, upon recommendation of the Finance Committee and by motion of Council, that falls within the minimum and maximum amounts shown below for each position:

**ADMINISTRATION**

	<u>Minimum</u>	<u>Maximum</u>
Village Administrator (per year)	\$ 40,000.00	\$ 60,000.00
Village Financial Officer (per year)	\$ 20,000.00	\$ 45,000.00

The above Office shall include the positions of Financial Director, Clerk of Council, Income Tax Administrator, and Utilities Clerk.

**POLICE DEPARTMENT**

	<u>Minimum</u>	<u>Maximum</u>
Chief of Police (per year)	\$ 35,000.00	\$ 55,000.00
Full Time Patrolmen (per hour)	\$ 13.00	\$ 21.00
Part-time Patrolmen (per hour)	\$ 13.00	\$ 18.00

**STREETS, WATER & SEWER MAINTENANCE**

	<u>Minimum</u>	<u>Maximum</u>
Utility Department Worker (per hour)	\$ 13.00	\$ 25.00
Street Department Worker (per hour)	\$ 13.00	\$ 25.00
Part-time Worker (per hour)	\$ 13.00	\$ 18.00

**FIRE CHIEF & ASSISSANT FIRE CHIEF**

	<u>Minimum</u>	<u>Maximum</u>
Fire Chief	\$ 3,000	\$ 5,000
Assistant Fire Chief	\$ 1,000	\$ 3,000

**CEMETERY SUPERINTENDENT**

Cemetery Superintendent	\$1,000	\$ 3,000

Any full-time hourly employee of the Street or Utility Department who obtains an Ohio EPA certification Class I, Class II or Class III license for Water Supply, Water Distribution, Wastewater Works, or Wastewater Collection shall be entitled to additional compensation as follows:


Each Class I license	\$2.00 per hour
Each Class II license	An additional \$ 1.00 per hour
Each Class III license	An additional \$ 1.25 per hour

The additional compensation will be paid on no more than two licenses per employee.


**SECTION TWO**
