

RESOLUTION NO. 2 -2022

A RESOLUTION ASSESSING PROPERTY OWNERS IN CARRIAGE WAY SUBDIVISION AND IN BAUGHMAN'S FIFTH ADDITION TO PAY PART OF THE EXPENSE OF OPERATING STREET LIGHTS

WHEREAS, the decorative street lights installed in Carriage Way Subdivision and in Baughman's Fifth Addition are of a type that requires additional cost for their use, and will benefit the abutting property-owners of Lots 539 and 540 in Baughman's Fifth Addition and Lots 552 through 569 in Carriage Way Subdivision, and

WHEREAS, the estimate of cost for the street lighting are on file in the office of the Village Administrator,

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Ansonia, Ohio, that:

SECTION ONE

The additional annual expense of the seven (7) decorative street lights installed in Carriage Way Subdivision and a part of Baughman's Fifth Addition is thirty-seven (\$37.00) Dollars per year per abutting property lot.

SECTION TWO

The cost of the additional annual expense for the operation of the seven (7) decorative street lights shall be assessed to the owners of Lots 539 and 540 in Baughman's Fifth Addition and Lots 552 through 569 in Carriage Way Subdivision, it being determined that these lots will be specifically benefited by said street lights. The assessments shall be levied, in proportion to the benefits which may result from the improvement to each lot, and shall be paid in five (5) annual installments of Thirty-Seven (\$37.00) Dollars per lot, to be collected for tax years 2023 through 2027.


SECTION THREE

SECTION FOUR


This Resolution shall take effect and be in full force at the earliest period allowed by law.


